It is intent to deepen this existing Basin Fruitland Coal well to approximately 2553' into the Pictured Cliffs formation.

It is anticipated the Pictured Cliffs is not productive in this wellbore. The existing tubing will be pulled, the hole will be circulated cleaned, additional footage will be drilled (85' beyond current TD or last significant coal) and again the hole will be cleaned, and then a 5 1/2" 15.5# J-55 liner will be installed at approximately 2200' - 2468'.

A mud log will be ran.
