Tail w/50 sx (72 cf) 50/50 POZ cmt w/5# gilsonite, 1/4# superflake, 0.2% superCR-1, 0.5% superFL-200, 0.2% gasX-300, & 0.3% airout. Circ. 10 bbls cmt to surface. Plan to pressure test casing during completion operations. Released drilling rig on 9/21/07.
