Cement with 550 sks Halco Light Premium, 2% CaCl₂, 10#/sk gilsonite, 1/8#/sk floccle tailed by 150 sks Class G, 1% CaCl₂, 1/4#/sk floccle (1221 cu.ft.). Plug down @ 7:45 am on 10/01/07. Circulate 90 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 1200 psi - ok.
