Pumped in 76sx (122cf - 22bbls) Type III cmt w/20% Flyash. Drop plug & displaced w/14bbls H2O. Circ no cmt to surface. WOC. RDMO @ 17:30hr on 10/2/07.

10/3/07 Top out cmt. Tag TOC @ 35'. Pumped in 15sx (21cf - 4bbls) Type III cmt w/ no additives. Circ .25bbl to surface. Install WH.
