Drilled 8 3/4" hole to 3,375' on 9/27/07, set 76 jts of 7", J-55 LT&C, 23# casing at 3,364'. Cemented lead w/550 sx (144 bbls) 50/50 POZ cement w/3% Gel, 5#/sx Gilsonite, 1/4#/sx Flocele, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (16 bbls) STD cement w/0.4% Halad 344. Circulated 50 bbls of cement to surface. Tested casing to 1,500 psi, held ok.
