9/8/07 PT 7" casing to 1500# - good test. RIH w/6-1/4" bit & tagged cement @ 3530'. D/O cement from 3503' to 7" shoe @ 3587'. Circ. hole. Continue drilling formation to 3783' (TD). TD reached 9/11/07. Circ. hole.

9/12/07 RIH w/underreamer. Underream 9 1/2" hole to TD @ 3738". Used natural & energized surges to c/o to TD for approx. 28 days. 10/9/07 RIH w/pre-perf'd 5-1/2" 15.5# liner & set @ 3783' w/TOL @ 3562' (25' overlap into 7" shoe). Perfs from 3629' - 3692' @ 4 SPF.
