BR/COP proposes to deepen this well into the Pictured Cliffs to improve operating conditions for the Fruitland Coal. Drillers total depth for the NP 403 was 3377'. COP would like to drill an additional 90' for a new TD of 3467'. We do not believe that the Pictured Cliffs is productive in the area without fracture stimulation, but we will utilize a mudlogger to monitor liberated gas while drilling the sump. Ownership for the Basin Fruitland Coal and Pictured Cliffs is common. P.C. non-prod. sump request granted 10/30/07-GEL
