10/15/07 spud 8-3/4" surface hole. Drilled to 129'KB. Ran 3 jts (121.90') of 7", 20#, J-55, ST&C new casing and set casing at 127'KB. Cemented with 50 sx (59 cu. ft.) of Type 5, 3% CaCl₂ and 1/4 #/sk celloflake. Circulated 5.0 bbls of good cement to surface. ✓

10/16/07 Nipped up the BOP. Pressure tested the BOP,choke manifold and casing to 250 psi - low and 1000 psi - high. ✓

10/18/07 TD 6-1/4" hole at 1905'. Ran 47 jts (1873.13') of 4-1/2", 10.5#, J-55, ST&C production casing and set casing at 1878' KB. Insert float is at 1857' KB and the top of marker joint is at 1423' KB. Cemented with 150 sx (309cu.ft.) of Type 5, 2% sodium metasilicate, 1/4#/sk celloflake, followed by 75 sx (90 cu. ft.) of Type 5, with 1/4# celloflake. Bumped plug to 1610 psi - float held OK. Circulated out 25 bbls of good cement. ✓
