XTO Energy Inc. spudded 13-1/2" surf hole on 10/14/07 & drilled to 335' (surf TD). Set 9-5/8", 36#, K-55 casing @ 318' on 10/15/07 & cemented w/265 sx Type V cement (15.6 ppg & 1.18 cuft/sx). Circ 15 bbl cement to surf. Finished cement job on 10/15/07. Pressure tested surf casing to 1000 psig for 30 min. Tested OK. ✓

Drilled 8-3/4" intermediate hole to 1982' (intermed TD) on 10/18/07. Set 7", 23#, K-55 casing @ 1982' on 10/18/07 & cemented w/185 sx Prem Lite cement (12.4 ppg & 1.99 cuft/sx) f/b 85 sx Class A cement (13 ppg & 1.58 cuft/sx). Circ 20 bbls cement to surf. Finished cement job on 10/19/07. Pressure tested intermed casing to 1500 psig. OK. ✓
