
1) MIRU PU. 2) TOH w/tubing. MIRU Wireline and mast trucks. RIH w/4-1/2" Baker CIBP & set at 6010' (casing collars at 5991' & 6043'). Pressure test CIBP to 3500 psig for 10 min. 3) Perf Mancos w/3-1/8" select fire casing gum fr/5690' - 5884' w/1 JSPP (Owen HSC-3125-306, 12 gm charges, 0.34" dia., 24.87" pene., 23 holes). 4) Frac Mancos perfs from 5690' - 5884' down 4-1/2" casing at 35 BPM w/52,000 gals 60Q, N2 foamed, 25# XL gelled, 2% KCl water (PurGel III) carrying 87,000# 20/40 Brady sand & 21,000# 20/40 Super LC RC sand. 5) TIH w/3-7/8" bit, 3 - 3-1/8" DC's, SN & 2-3/8" tubing. CO to CIBP @ 6010'. TOH w/tubing. TIH w/NC, SN & tubing. Land tubing at mid perforations.
