XTO Energy Inc. spudded 13-1/2" surf hole on 10/24/07 & drilled to 246' (surf TD). Set 9-5/8", 36#, J-55 casing @ 240' & cemented w/130 sx Class A cement (15.5 ppg & 1.18 cuft/sx). Circ 15 bbls cement to surf. Pressure tested surf casing to 1000# for 30 min. Tested OK.

Drilled 6-1/8" intermediate hole to 1777' (int. TD) on 11/10/07. Set 7", 23#, J-55 casing @ 1777' & cemented w/175 sx Class A cement (12.4 ppg & 1.99 cuft/sx) f/b 85 sx Class A cement (13 ppg & 1.58 cuft/sx). Circ 38 bbls cement to surf. Pressure test will be report on next sundry.
