8-27-07: Started the Frac job (1937 MSCF N2 WITH 112733 GALS OF 70Q DELTA 200 WITH EXPEDITE FRAC FLUID.) Excluding 5161 gals foam flush @ avg of 44.2 bpm with avg.69.7Q pumped total of 1441 gals of 20/40 Ottawa Sand.

9-4-07: Set 2 3/8" tbg @ 5636.32'. Rig down and move off location.
