Elm Ridge Exploration Co, LLC spud this well on 11-25-07. We drilled a 12-1/4" hole to 395' on 11-25-07. We then drilled a 7-7/8" hole to 335' on 11-26-07. We ran 8-5/8" 24# J-55 casing to 390.03' on 11-26-07. Pumped 320 sks of Type G cement w/ 2% CACL and 1/8# polyflake. Circulated cement to surface w/ 22 bbls of good cement to surface. Pressure tested well to 1500 PSI on 11-26-07 for 30 minutes. Marco Hecman with the BLM was notified, but not present to witness cementing. ✓
