Tops of the perf joints @ 6005', 6755', 5502', 5252', 5002', 4755', 4502', & 4254'. Pumped 35 bbls 20% HCL acid to dissolve the plugs. Landed 2-3/8" 4.7# J-55 tbg @ 4103'. Ran pump & rods & initiated pumping. Released rig on 11/18/07.
