XTO Energy Inc. spudded 12-1/4" surface hole on 10/31/07 & drilled to 385' (surf TD). Set 8-5/8", 24#, J-55, ST&C casing @ 375' & cemented w/300 sx Class G cement (15.6 ppg & 1.19 cuft/sx). Circulated 20 bbls cement to surf. Finished cement job on 10/31/07. Pressure tested surface casing to 700 psig for 30 min on 11/1/07. Tested OK.
