Workover, Lined:

ConocoPhillips proposes to construct a workover pit. Based on ConocoPhillips' interpretation of the Ecosphere's risk ranking criteria, the workover pit will be a lined pit as detailed in ConocoPhillips' General Plan dated June 2005 on file at the NMOCD office. ConocoPhillips anticipates closing the pit according to the November 1, 2004 Guidelines.

On this workover, a vent/flare pit may be the only pit that will be required. Under this circumstance, a portion of this vent/flare pit will be designed to manage fluids, and that portion will be lined, as per the risk ranking criteria.
