Elm Ridge Exploration Co, LLC spud this well on 12-9-07. We drilled a 12-1/4" hole to 395' on 12-9-07, we then ran 8-5/8" 24# J-55 casing to 392'. On 12-9-07 Pumped 320 sks of type G cement w/ 2% CCL and Polyflake. Circulated cement to surface w/ 20 bbls of excess to surface. Pressure tested well to 1500 PSI on 12-9-07. Several calls were made to the Farmington BLM office to notify them of the cement job, there were no returned phone calls from the BLM or no one sent to witness job. ✓
