Drilled 7-7/8" hole to 2020' ^{TD} on 12/13/07. Set 5-1/2", 15.5#, J-55 casing @ 2020' on 12/14/07 & cemented w/280 sx Type V cement (12.3 ppg & 1.89 cuft/sx) f/b 110 sx Type V cement (15.6 ppg & 1.18 cuft/sx). Circ 45 bbls cement to surf.

Production casing will be tested upon completion.
