Elm Ridge Exploration Co, LLC reached a TD of 5115' on 1-9-08. With a 7 7/8" drilled hole we ran 125 joints of 5 1/2" 15.5# J-55 casing to 5100' on 1-10-08, we then pumped 333 sks of 50/50/G/POZ Cement and tailed in w/ 545 sks of 65/35/G/POZ cement. Circulated cement to surface with 22 bbls of good cement to the surface on the 1st stage and 12 bbls of good cement to surface on the 2nd stage. Pressure tested well to 1500 PSI for 30 plus minutes. Mark Kecman with the BLM was notified but was not present to witness the cement job.
