

Set 8-5/8", 24#, J-55, ST&C casing @ 375' on 01/05/2008 & cemented w/280 sx Type A cement (15.6 ppg & 1.18 cuft/sx). Circ 27 bbls cement to surf. Finished cement job on 01/05/2008. Pressure tested casing to 1000 psig f/30 min. Tested OK. ✓
