Devon Energy Production Company, Inc. hereby gives notification to modify original Down Hole Commingle, #93842, with the isolation of the Dakota zone using a retrievable bridge plug set at 7,940'. Perforations were added to the W.C. Basin Mancos zone at a depth of 7,794' to 7,833' totaling 15 holes. The perforations were treated with 2,947 gal 15% HCL and a total of 86,363 gal of Delta 200 frac fluid was used with 85,759# 20/40 Ottawa sand. On 12/16/07 228 jts of 2 3/8" tubing was landed with a 4 1/2" Weatherford Aeroset Packer @ 7,688'
