XTO Energy Inc. spudded 12-1/4" surf hole on 01/25/2008 & drilled to 385' (surf TD). Set 8-5/8", 24#, J-55, ST&C casing @ 376' on 01/26/2008 & cemented w/300 sx of Type V cement (15.6 ppg & 1.19 cuft/sx). Circ 25 bbls cement to surf. Finished cement job on 01/26/2008. Pressure tested surf casing to 1000 psig f/30 min. Tested OK.
