On December 20, 2007; We RU wire line truck and ran bond log from 1200' to surface, found top of good cement at 950' but it was a not the best quality up to 620' so we decided to shoot holes at 600' RU Halliburton broke circulation then pumped 50 bbls of fresh water then went into cement, pumped a total of 200 sks of cement, got full returns with 12 bbls of good cement to surface.
