XTO Energy Inc. spudded 12-1/4" surf hole on 01/21/2008 & drilled to 378' (surf TD). Set 8-5/8", 24#, J-55, ST&C casing @ 362' on 01/22/2008 & cemented w/250 sx Type III cement (15.6 ppg & 1.20 cuft/sx). Circ 5 bbls cement to surf. Finished cement job on 01/22/2008. Pressure tested casing to 800 psig f/30 min. Tested OK.
