10/10-10/15/03 Set CIBP at 2980', dump 50' cement from 2980' to 2930'. Cut off 5-1/2" liner at 2445', latch onto liner at 2210', POH with 8 joints 235' 5-1/2" casing. GIH with 75 joints 2-3/8" EUE 8rd tubing and 7" Baker Lok-set packer, set at 2420', pressured to 500 psi with packer fluid, held okay. Swabbed tubing, recovered 22 barrels water, well kicked off flowing 240 MCF/D. Shut well in overnight. 16 hour SI tubing pressure 210 psi. Complete well as producing gas well.
