Cement 1st stage with 360 sks 50/50 poz, 2% CaCl2, 0.3% Halad-9, 0.1% CFR-3, 5#/sk gilsonite, .125#/sk flooele (489 cu.ft.). Plug down @ 9:39 pm on 02/02/08. Circulate 20 bbls cement to surface. Circulate between stages. Cement 2nd stage with 505 sks Halco Light, 2% CaCl2, 10#/sk gilsonite, .125/sk flooele tailed by 50 sks Class G, 1% Cacl2 (1013 cu.ft.). Plug down @ 4:20 am on 02/03/08. Circualte 40 bbls cement to surface. WOC. NU BOP. Test casing and BOP to 1200 psi - ok. ✓
