Elm Ridge Exploration Co, LLC reached a TD of 1375' on 4-20-06. We ran 33 joints of 5 1/2" 15.5# J-55 casing to 1366'. We then Pumped 155 sks of STD B cement in the first stage. Second stage we tailed in w/ 110 sks STD B cement w/ 2% CACL. Circulated cement to surface w/ 15 bbls of excess. Pressure tested well to 1500 PSI for 30 plus minutes.
