Circ 25 bbls cement to surf. Cemented 2nd stage w/460 sx Type V cement (11.4 ppg & 2.86 cuft/sx) f/b 100 sx Type III cement (14.5 ppg & 1.39 cuft/sx). Circ 60 bbls cement to surf. Finished cement job on 2/21/08.
