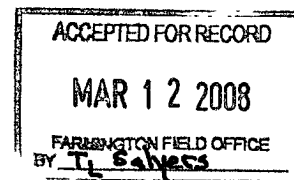
13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recomple horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. On 01/05/08, ran 3 joints of new 8-5/8", 24#, 8rd K-55 STC surface casing set at 134' KB (12-1/4" hole TD at 139'). Cemented casing with 120 sacks Type G cement with 2% CaCl2 and 1/4#/bbl superfine (Yield=1.18 ft3/sk and wt=15.6 lb/gal). Displace with 7.5 BBls water. Plug down at 10:03AM. Good returns throughout job. Returned approximately 10 BBls of cement to pit.

Pressure test on casing to 1000 psi. ✓
