On 3-7-08 we ran 139 joints of 5 1/2" 15.5# J-55 casing to 5329' production hole size is 7 7/8". 1st stage of cementing went as follows 3-7-08: We pumped 412 sks of 50/50/G/POZ cement. Circulated 30 bbls of good cement to surface. Second stage of cementing went as follows 3-8-08. We pumped 547 sks of 65/35/G/POZ. Circulated 80 bbls of good cement to the surface. Pressure tested well to 1500 PSI for 30 minutes plus. Marko Kecman with the BLM was notified but not present to witness job
