Pumped pre-flush of 10 bbls mud flush. Pumped 75 sx (120cf-21 bbls) Type 1-11 Cement w/20% Flyash. Dropped wooden plug and displaced w/14 bbls H2O. Bumped plug @ 200#. Circ 2 bbls cement to surface. RD & RR and equipment. Dig cellar, install WH.

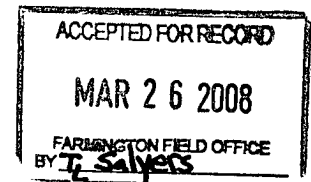
