Black Hills Gas Resources intends to pull the production tubing, set a temporary plug over the Pictured Cliffs @ +/- 3675'. This plug will be set as a safety measure to allow the drilling rig to drill the Jicarilla 464-31 #233 horizontal Pictured Cliffs well from the existing well pad. It is estimated that the drilling and completion operations of the new well will take 30-60 days from commencement of the drilling.
