Drilled 8-3/4" intermediate hole to 1805' (int TD) & set 7", 26#, K-55 casing @ 1791' on 3/16/08. Cemented w/150 sx Type V cement (12.4 ppg & 1.99 cuft/sx) f/b 85 sx Type V cement (13 ppg & 1.58 cuft/sx). Circ 10 bbls cement to surf. Finished cement job on 3/16/08.
