This plug will be set as a safety measure to allow the drilling rig to drill the Jicarilla 459-17 #741 horizontal Pictured Cliffs well from the existing well pad. It is estimated that the drilling and completion operations of the new well will take 30-60 days from commencement of the drilling.
