Set cmt ret @ 1070' & sq csg leak w/332 cf cmt w/2% Cacl2. Circ cmt out bradenhead valve. Drilled out cmt ret & cmt & pressure tested sq holes to 500 psi - OK. Sq job & pressure test witnessed by Val Jameson. Drilled out CIBP @ 1980' & CO to 2250'. Ran tbg. pump, & rods, & resumed production. Released rig on 3/21/08.
