03/31/08 spud 8-3/4" surface hole. Drilled to 135' KB. Ran 3 jts (123.49') of 7", 20#, J-55, ST&C new casing and set casing at 128' KB. Cemented with 65 sx (77 cu ft) of Type 5, 3% CaCl₂ and 1/4 #/sk celloflake. Circulated 6.0 bbls of good cement to surface.

04/1/08 Nipped up the BOP. Pressure tested the BOP, choke manifold and casing to 250 psi - low and 1000 psi - high.

04/3/08 TD 6-1/4" hole at 1980'. Ran 51 jts (1971.83') of 4-1/2", 10.5#, J-55, ST&C production casing and set casing at 1977' KB. Insert float is at 1961' KB and the top of marker joint is at 1544' KB. Cemented with 150 sx (309 cu. ft.) of Type 5, 2% sodium metasilicate, 1/4 #/sk celloflake, followed by 75 sx (89 cu ft.) of Type 5, with 1/4 # celloflake. Bumped plug to 1500 psi. Circulated 30 bbls of cement to surface.
