Elm Ridge Exploration CO LLC; has spud the above well on 4-08-08. We drilled a 12 1/4" hole to 382' on 4-9-08 then ran 9 joints of 8 5/8" 24# J-55 Casing to 376'. We then pumped 320 sks of Type G cement with 2% calcium chloride and 1/8# polyflake, circulated 25 bbls of good cement to surface. Pressure tested the well to 1500 PSI for 30 plus minutes. The BLM was notified, but was not present for job ✓
