Elm Ridge Exploration Co, LLC reached a TD of 5346' on 3-21-08. On 3-23-08 we ran 126 joints of 5 1/2" 15.5# J-55 casing to 5340'. Hole size 7 7/8". 3-23-08 Stage one of cementing, we pumped 412 sks of 50/50/G/POZ with 20 bbls of good cement to surface. 3-24-08 Second stage of cementing, pumped 547 sks of 65/35/G/POZ with 38 bbls of good cement to surface. Pressure tested well to 1500 PSI for 30 plus minutes. Marko Kecman with the BLM was notified but not present for job.
