Drilled 12 1/4" hole to 302' on 12/9/05, set 8 jts of 9 5/8", H-40, ST&C, 32.3# casing at 298'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaC1 and 1/4# PSX Floseal. Circulated 5 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,720' on 12/15/06, set 86 jts of 7", J-55 LT&C, 23# casing at 3,715'. Cemented lead w/485 sx (125 bbl) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/135 sx (35 bbl) STD, 4/10% Halad 344. Top of cement at 386', verified through Jim Lovato before drilling out. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 8,134' on 12/19/05, set 194 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,131'. Cemented lead w/500 sx (135 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL. No cement to surface, top of cement at 334'. Landed 2 3/8" production tubing at 8,006'.
Tested casing to 1500 psi.
