Parawon Operating LLC would like an exception to the BLM pressure test rule of 500 psi. We plan to acidize this well under a packer. We believe that any pressure test on this well's 50 year old casing could be very destructive and could result in the loss of the well.

This well's 50 year old casing will not experience over 50 psi under normal producing conditions. Even the hydrostatic column of water (necessary to pressure test) would be more 50 psi on the casing. The column of water necessary to pressure test the casing could be very destructive to the formation. Aquifers above the producing formation in this well are very limited or non-existent. Any and all casing leaks can be readily identified by the loss of fluid production and appearance of drilling mud in the wellbore. A recent example is NE Hogback Unit #7. Parawon constantly monitors production for any fluid loss or the appearance of drilling mud.
