

Devon Energy Production Company, L.P. would like to give notice of remedial work to be performed on the 4 1/2" casing in the above named well. It is estimated that perforations below the DV Tool will be placed at 6,330' & 5,720'. The perforations will be cemented with approximately 25 bbls 50/50 POZ. There will be perforations above the DV Tool at 5,600' and cemented with approximately 120 bbls 50/50 POZ. Cement is designed to cover at a minimum 1,000' into the 7" casing.
