This well produces approximately 33 bbls of water per day. This water is stored on location, in two (2) 500 BBL steel tanks with closed tops, until it is transported to Pump Canyon Disposal by a Key Energy Service, Inc.

Water from the separator, down stream of the compressor, is stored on lease in a 120 bbl steel tank with expanded metal top and secondary leak detection, until it is trucked by Key Energy Services, Inc. to either the Key Four Corners, Inc. Water Disposal Facility or Basin Disposal, Inc.
