Circ 60 bbls to surf. Cemented 2nd stage w/785 sx Prem Lite cement (12.1 ppg & 2.1 cuft/sx) f/b 200 sx prem Lite cement (12.5 ppg & 1.98 cuft/sx). Circ 120 bbls cement to surface. Finished cement job on 12/1/07.
