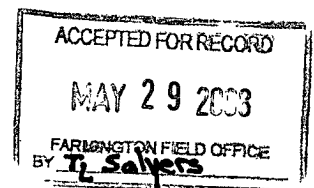

Circulate 45 bbls. cement to surface. WOC. RD Superior. NU BOP. Test casing & BOP to 1200 psi - ok. ✓
