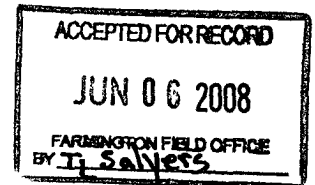

Liner has 8 preperfed & plugged joints w/tops @ 4553', 5215', 5684', 6116', 6545', 6976', 7410', & 7841'. Each preperfed liner joint has 28-0.75" holes. Released rig on 6/1/08. Waiting on completion rig.
