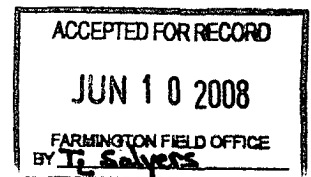
5/13/08 Blue Jet ran a Gamma Ray / Neutron log from 1828' to 1100'

5/16/08 Frac w/ 784 bbls of borate crosslinked gel with 5,000# of 40/70 & 60,000# of 20/40 Brady sand.

5/30/08 RU Hurricane Well Service. Clean out to PBTD. Ran 53 jts of 2-3/8", 4.7#, J-55, EUE8rd tubing and set @ 1732' KB.

Ran pump and rods. Turned well over to production.
