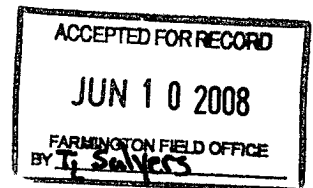

5/30/08 Clean out to PBTD at 6990' with air. Ran 214jts of 2-3/8", 4.7#, J-55, EUE8rd tubing and set at 6892' KB.
SI well. Turned over to Production Dept.
