Devon Energy Production Company, L.P. would like to report remedial work to the 7" casing on the above named well. The 4 1/2" casing was backed off at 2,226'. Squeeze holes were shot at 2,150', 4 SPF, 120° Phasing, 0.34" EHD then 10 bbls dyed cement was run followed by 250 sx (65 bbls 50/50 POZ "G" w/3#/sx Gilsonite, 0.1% CFR-3, 0.4% Halad 344. Tested remedial work of 7" casing to 500 psi, held ok and ran CBL from 2,114' to surface determining TOC is now at 400'. Using a Bowen 4 1/2" casing patch RIH to 2,226' set casing to energize seal, test to 500 psi, held ok.

Devon Energy Production Company, L.P. would like to give notification of tubing set in the above well. On 6/18/08 188 jts of 2 3/8", 4.7#, J-55, tubing was set at a depth of 7,933' with a Model R Packer set at 5,941'.
