
Black Warrior WL ran GR/cement bond log from 9,570' - surf. TOC @ 2,800' per cement bond log. Per phone conversation with Dan R. w/BLM, XTO proposes to set CBP @ +/-2,900', shoot squeeze hole @ +/-2,770', set CICR on tbg @ +/-2,695' and cement casing back to surface. Cement job will consist of +/-620 sx of +/-12.4 ppg lead slurry & +/-100 sx of +/- 15.6 ppg tail slurry. Cement volume will be calculated based on open hole caliper volume with 30% excess. XTO proposes to proceed upon approval of this sundry & has notified Henry Villanueva w/OCD on 5/27/08.
