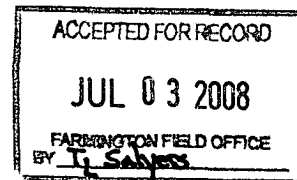

Cemented lead w/550 sx (142 bbls) 50/50 POZ cement w/3% Gel, 5#/sx Gilsonite, 1/4#/sx Flocele, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (16 bbls) STD cement w/0.4% Halad 344. Circulated 30 bbls of cement to surface. Tested casing to 1,500 psi. *good test?*
